RE: Possible abandonment of Sherman Elementary School

## Mr. Martin:

It had previously come to the attention of South Sherman Fire, City of Grass Valley and Sherman County, that the School District was strongly entertaining the idea of building a one-site facility at Moro for all grade levels and therefore, leaving the school building currently being used in Grass Valley vacant. On December 7<sup>th</sup>, 2012 a multiple agency meeting including, South Sherman Fire, chief and board members; City of Grass Valley Administrator, Mayor and council member; architect and structural engineer to examine possible adjustments to building for use; Chairman of the Board for Sherman School District; Judge Thompson, Sherman County; principal for Sherman Elementary; Grant writer and possible funder from PARC. We met at the school facility, toured the entire building and had a think tank of possibilities for the site.

South Sherman Fire and Rescue and City of Grass Valley have been trying some kind of collaboration of a mutual use facility for some time; it seemed prudent for us to look into the possible use of an already standing, pretty much state of the art facility, the school building; when we learned that you were needing to present the community with an alternative use, or leave a perfectly good building standing empty.

We would like to continue to pursue that possibility as a group. We have continued to keep all of our options open; but we must make a move at some point to continue our pursuit of a facility. We are asking the school facilities committee if they are, indeed, interested in being part of a collaborative effort to do something positive for our community, knowing that the movement of the school facility will have a big impact on this community.

South Sherman Fire and City of Grass Valley have had positive feedback so far, as to the idea of a group effort continuing to utilize a building already built with tax dollars.

Some ideas that have been approached with positive feedback within the community and from outside agencies:

- \* Fire and Rescue building;
- \* City Hall with meeting space for ALL agencies;
- \* Dormitories as part of the Fire and Rescue building that can be rented out with classrooms for driving schools and training facilities for other state/local agencies;
- \* Senior meals being provided through the state of the art kitchen;
- \* Possible food services, deli, etc


- \* Meeting/conference space
- \* Incubators for possible new businesses
