Position Description:

The board, staff, and community of the Sherman County School District are seeking an outstanding principal to lead our comprehensive K-12 school (Sherman County School) that underwent an addition and extensive remodel prior to the 2016-17 school year. Sherman County School has an enrollment of approximately 264 students, providing an ideal environment for an administrator dedicated to the success of each individual student. The certified and classified staff members are completely dedicated to providing the very best educational experiences for all students.

This position shall report to the superintendent and requires an administrative and teaching certificate with at least 3 years of experience as an administrator and the ability to perform additional assignments. The successful candidate must rely on extensive experience and judgment to plan and accomplish goals and lead and direct the work of others. A wide degree of creativity and latitude is expected.

The successful candidate must demonstrate skillful leadership and work cooperatively with a dedicated staff and community; be a leader who participates in the life and activities of the school community; possess excellent communication skills; exhibits dynamic leadership qualities; as well as demonstrates personal and professional honesty and integrity.

The principal is the instructional leader of our comprehensive K-12 school, responsible for establishing an instructional vision and a focused plan for improving student achievement; monitoring and supervising

instruction; evaluating and supporting teachers in improving their instructional practice; creating a community of continuous learning for all staff and students; student discipline; and fostering a culture of high expectations for all students. The principal shall also ensure all school activities are within budgetary guidelines.

Augmenting a district-wide commitment to academic achievement, the Sherman County School District offers state-of -the art technology including high speed internet, interactive video, on-line classes and video on demand services to support and enhance instructional programs. The school district has consistently earned strong ratings from the Oregon Department of Education, and has a solid local funding base.

Community Description:

Sherman County enjoys four distinct seasons. Summers are warm, dry and clear. Winters are relatively mild; with occasional heavy snowfall. Wheat is the most important crop here, but the wind farm industry has become a major economic boost for the area. Windsurfing on the Columbia and boating, hunting and fishing are easily accessible from the area.
